ANNUAL GENERAL MEETING TO BE HELD ON 30 APRIL 2025

1. Manulife US Real Estate Management Pte. Ltd., as manager of Manulife US Real Estate Investment Trust (“**Manulife US REIT**”, and as manager of Manulife US REIT, the “**Manager**”), wishes to announce that the annual general meeting (“**AGM**”) of the holders of units in Manulife US REIT (“**Units**” and the holders of Units, “**Unitholders**”) will be convened and held at **Stephen Riady Auditorium @ NTUC, NTUC Centre, Level 7, One Marina Boulevard, Singapore 018989** on **Wednesday, 30 April 2025 at 2:30 p.m.** (Singapore time).
2. **Notice of AGM and Proxy Form.** Printed copies of the Notice of AGM and the proxy form (the “**Proxy Form**”) will be mailed to Unitholders. Copies of these documents will also be sent to Unitholders by way of electronic means via publication on Manulife US REIT’s website at the URL <https://www.manulifeusreit.sg> and on the SGX website at the URL <https://www.sgx.com/securities/company-announcements>.
3. **No option for Unitholders to participate virtually.** This AGM is being convened and will be held in a wholly physical format. There will be no option for Unitholders to participate virtually.
4. **Submission of questions in advance of the AGM.** Unitholders, including SRS investors, or where applicable, their appointed proxy(ies) will be able to ask questions in person at the AGM.

Additionally, Unitholders can also submit questions related to the resolutions to be tabled for approval at the AGM to the Chairman of the AGM to be addressed in advance of the AGM. In order to do so, Unitholders must submit their questions in the following manner by **2:30 p.m.** on **Tuesday, 22 April 2025**.

- (a) If submitted electronically via email to srs.teamE@boardroomlimited.com (with subject title “**MUST AGM Questions**”); or
- (b) If questions are submitted by post, the letter to be addressed to and deposited at the registered office of Manulife US REIT’s Unit Registrar, Boardroom Corporate & Advisory Services Pte. Ltd, at 1 Harbourfront Avenue, #14-07 Keppel Bay Tower, Singapore 098632.

Unitholders who submit questions by email or by post must provide the following information:

- (i) the Unitholder's full name;
- (ii) the Unitholder's address; and
- (iii) the manner in which the Unitholder holds Units in Manulife US REIT (e.g., via CDP or SRS).

The Manager will endeavour to address all substantial and relevant questions (which are related to the resolutions to be tabled for approval at the AGM) received from Unitholders in advance of the AGM by the **22 April 2025** submission deadline, by publishing the responses to such questions on Manulife US REIT's website at the URL <https://www.manulifeusreit.sg> and the SGX website at <https://www.sgx.com/securities/company-announcements> prior to the AGM, by **2:30 p.m.** on **Friday, 25 April 2025**. Any questions submitted after the 22 April 2025 submission deadline may not be addressed in advance of the AGM. Where substantially similar questions are received, the Manager will consolidate such questions and consequently, not all questions may be individually addressed.

5. **Persons who hold Units through relevant intermediaries.** Persons who hold Units through relevant intermediaries, other than SRS investors, and who wish to participate in the AGM are not to use the Proxy Form and should contact the relevant intermediary through which they hold such Units as soon as possible in order for the necessary arrangements to be made.

Persons who hold Units through relevant intermediaries, other than SRS investors, may vote at the AGM (i) by being appointed as proxies by their respective relevant intermediaries, or (ii) specify their voting instructions to / arrange for their votes to be submitted with their respective relevant intermediaries.

SRS investors:

- (a) may vote at the AGM if they are appointed as proxies by their respective SRS Operators, and should contact their respective SRS Operators if they have any queries regarding their appointment as proxies; or
- (b) specify their voting instructions to / arrange for their votes to be submitted with their respective SRS Operators, and should approach their respective SRS Operators by **5:00 p.m.** on **Monday, 21 April 2025**, being at least seven (7) working days before the date of the AGM, to ensure their votes are submitted.

For avoidance of doubt, SRS investors will not be able to use the Proxy Forms and appoint third party proxy(ies) to vote at the AGM on their behalf.

6. **Key dates/deadlines.** The table below sets out the key dates/deadlines for Unitholders to note:

2:30 p.m. on 27 April 2025 (Sunday)	Deadline for Unitholders to submit the Proxy Forms.
Date and Time of AGM: 2:30 p.m. on 30 April 2025 (Wednesday)	Unitholders or, where applicable, their duly appointed proxy(ies) may attend the AGM in person at the Stephen Riady Auditorium @ NTUC, NTUC Centre, Level 7, One Marina Boulevard, Singapore 018989. <u>There will be no option to participate virtually.</u>
