A total of 69,836,787 issued and paid-up ordinary shares (the "Shares") in the capital of the Company were tendered in acceptance of the mandatory cash offer by CIMB Bank Berhad, Singapore Branch, for and on behalf of the Offeror, to acquire all of the Shares, other than those already owned, controlled or agreed to be acquired by the Offeror and parties acting in concert with it in the period from 7 February 2014 to 7 April 2014 (the "Offer"). The Offer closed on 7 April 2014.

Of the 69,836,787 Shares, the Offeror had on 9 April 2014 disclosed its direct interest in 151,109,382 Shares and its deemed interest in 1,233,219 Shares which at that date was pending settlement of the consideration due.

Further to the notification made by the Offeror on 9 April 2014, the remaining 1,233,219 Shares have since been settled and transferred to the Offeror on 10 and 11 April 2014, and as such, the Offeror has a direct interest in all 69,836,787 Shares.

There is no change in the percentage level of interest of the Offeror and this notification is provided for the purposes of the Company's records only.
