The substantial shareholding interest of Pacific Landmark Holdings Limited ("Pacific Landmark") in OUE ceased as a result of a reorganisation exercise (the "Reorganisation Exercise"), whereby all the shares held by Pacific Landmark in Lippo ASM Asia Property Limited ("LAAPL") were transferred to HKC Property Investment Holdings Limited ("HKC Property").

Following the Reorganisation Exercise, Pacific Landmark no longer holds any voting shares in LAAPL and accordingly, ceased to have a deemed interest in the 618,916,410 shares in OUE ("Shares") in which LAAPL has an interest (the "Relevant OUE Shares").
