Tritech International Holdings Pte Ltd ("TI") was a controlling shareholder of Tritech Group Limited ("TGL") and was placed in voluntary liquidation on 28 August 2015. Dr Cai Jungang held an approximate 15.55% shareholding interest in TI and had received in proportion to his shareholding interest in TI, 48,226,267 ordinary shares and 24,113,133 warrants of TGL following an interim capital distribution by the Liquidator satisfied by an in-specie distribution. The shares have been credited into the respective shareholders' CDP accounts on 9 June 2016.
