The Board of Directors (the "**Board**") of OneApex Limited (the "**Company**") (formerly known as Chew's Group Limited) refers to the Circular in relation to, *inter alia*, the Proposed Change of Name of the Company from "Chew's Group Limited" to "OneApex Limited" and the adoption of the Chinese name "亿高有限公司" for identification purposes.

Further to the extraordinary general meeting of the Company held on 31 January 2019 where the special resolution relating to the Proposed Change of Name was duly passed, the Board wishes to announce that the Notice of Special Resolution for Change of Name has been lodged with the Accounting and Corporate Regulatory Authority of Singapore ("**ACRA**") on 31 January 2019 and ACRA has issued the Notice of Change of Name to confirm that the Company had resolved to change its name to "OneApex Limited" with effect from 31 January 2019.

The Company has arranged with the SGX-ST to change its trading counter name on the Catalist of the SGX-ST. The change of the Company's trading counter name will take effect at 9.00 a.m. on 7 February 2019 and the new trading counter name will be "OneApex".
