INTRODUCTION

The board of directors (the "Board" or "Directors") of British and Malayan Trustees Limited (the "Company") refers to:

COURT HEARING TO SANCTION THE SCHEME

The Board wishes to announce that the Company has filed an application to the Court to sanction the Scheme and that the Court has directed that the application be heard at 3.00 p.m. on 17 July 2017.

Subject to the grant of the order of the Court sanctioning the Scheme under Section 210 of the Companies Act (the "Court Order") and the satisfaction (or, where applicable, waiver) of all the Scheme Conditions, the Scheme shall become effective and binding upon the lodgement of the Court Order with the Accounting and Corporate Regulatory Authority of Singapore ("ACRA").

LAST DAY OF TRADING OF SHARES

Shareholders should note that, subject to the grant of the Court Order, the last day of trading of the Shares on the SGX-ST will be on 19 July 2017.

NOTICE OF BOOKS CLOSURE
