ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Lendlease Global Commercial Trust Management Pte. Ltd., as manager of Lendlease Global Commercial REIT ("LREIT", and the manager of LREIT, the "**Manager**"), wishes to announce that 17,045,500 new units in LREIT ("**Units**") will be issued at an issue price of S\$0.5158 per new Unit on 26 September 2024 pursuant to LREIT's Distribution Reinvestment Plan ("**DRP**") in respect of the distribution of S\$0.017700 per Unit for the period from 1 January 2024 to 30 June 2024 (the "**2H FY2024 Distribution**").

The new Units will be credited to the securities accounts of unitholders of LREIT ("**Unitholders**") who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 am on 26 September 2024.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issue of the new Units, the number of issued Units will increase from 2,376,578,012 to 2,393,623,512.

2H FY2024 Distribution payments to eligible Unitholders who did not elect to participate in the DRP will be paid in cash on 26 September 2024.
