QUARTERLY UPDATE PURSUANT TO RULE 1313(2) OF THE LISTING MANUAL

The Board of Directors of China Essence Group Ltd (the "Company", or together with its subsidiaries, the "Group") refers to the announcement dated 3 June 2014 in relation to the Company being placed on the watch-list. For the three-months ended 31 March 2016 ("4Q FY2016"), the Group is not able to finalise and announce its Full Year financial statements as the Company is unable to obtain full information on the state of affairs of the Group from Mr Zhao Libin, the former Executive Chairman and Chief Executive Officer of the Group ("CEO"), or the management of the Company. Both the former Executive Chairman /CEO and management have continued to remain uncontactable.
