"Together with our industry partners, Wei Loong will oversee all R&D efforts on-site in our PRC farms, starting off with the initial focus area of abalone genetics, which can potentially enhance the yield and quality of our biological assets," added Mr Koh.

Mr Chan brings with him over two decades of rich experience and network in the fields of zoology, molecular biology, animal biology and paediatrics. Prior to his appointment, Mr Chan took on a dual role at Republic Polytechnic – both as an Assistant Director (Capability & Industry) in the School of Applied Science and the Programme Chair for the Diploma in Marine Science & Aquaculture (DMAC).

The latter is a new and niche diploma where Mr Chan was heavily involved in planning and starting up, and till date, remains as the only Pre-Employment Training Course in Singapore that exposes students to marine science and aquaculture studies.

Mr Chan holds a Master of Science from the Department of Paediatrics, Yong Loo Lin School of Medicine, National University of Singapore as well as a Honours Degree from the Department of Zoology, Faculty of Science, National University of Singapore.
