ENTRY INTO FACILITY AGREEMENT AND RULE 704(31) DISCLOSURE

M&C REIT Management Limited as manager of CDL Hospitality Real Estate Investment Trust ("**H-REIT**", and the manager of H-REIT, the "**Manager**") and M&C Business Trust Management Limited as trustee-manager of CDL Hospitality Business Trust would like to announce that DBS Trustee Limited (in its capacity as trustee of H-REIT, the "**H-REIT Trustee**") has today entered into a facility agreement (the "**Facility Agreement**") for the grant of a multicurrency revolving credit facility of S\$200,000,000. The H-REIT Trustee is currently also party to various facility agreements which require the facilities granted thereunder to be prepaid in the event (the "**H-REIT Relevant Event**") that the Manager ceases to be the manager of H-REIT and a replacement manager reasonably acceptable to the relevant lender is not appointed by the date of such cessation (or such later date as the relevant lender may agree).

If the H-REIT Relevant Event occurs, the aggregate level of facilities that may be affected is approximately S\$1,041.2 million (excluding interest) as at the date of this announcement.

As at the date of this Announcement, the H-REIT Relevant Event has not occurred.
