PROFIT GUIDANCE FOR FULL YEAR ENDED 31 DECEMBER 2025 (“FY2025”)

The Board of Directors (the “**Board**”) of CNMC Goldmine Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to announce that the Group is expecting a significant overall improvement in its net profit for FY2025, as compared to the net profit recorded for the corresponding period ended 31 December 2024 (“**FY2024**”).

The unaudited profit for FY2025 shows a significant improvement compared to FY2024, attributable to higher average realised prices for gold and silver, coupled with higher production output at both the CIL and flotation processing plants.

Shareholders’ attention is also drawn to the Company’s significant improvement in its profit reflected in its unaudited financial statements for the half year ended 30 June 2025.

The foregoing profit-guidance is based on a preliminary review of the Group’s unaudited consolidated financial results for FY2025. Details will be disclosed when the Company releases the Group’s unaudited consolidated financial results for FY2025 on or before 1 March 2026.
