## PAYMENT OF BASE MANAGEMENT FEE BY WAY OF ISSUE OF NEW STAPLED SECURITIES IN FAR EAST HOSPITALITY TRUST

FEO Hospitality Asset Management Pte. Ltd. (the "REIT Manager"), as manager of Far East Hospitality Real Estate Investment Trust ("Far East H-REIT"), and FEO Hospitality Trust Management Pte. Ltd. (the "Trustee-Manager"), as trustee-manager of Far East Hospitality Business Trust ("Far East H-BT"), wish to announce that 2,856,158 stapled securities in Far East Hospitality Trust ("Far East H-Trust"), each stapled security comprising one unit in Far East H-REIT and one unit in Far East H-BT, have been credited on 27 October 2016 to the accounts of the REIT Manager at an issue price of approximately S\$0.5989 per stapled security as payment of base management fee for the period 1 July 2016 to 30 September 2016.

The issue price per stapled security was based on the volume weighted average price for a stapled security for all trades on the Singapore Exchange Securities Trading Limited for the last ten (10) business days of the relevant period in which the Management Fee accrues i.e. 19 September 2016 to 30 September 2016.

For the financial year ending 31 December 2016, FEO Hospitality Asset Management Pte. Ltd., as manager of Far East H-REIT, has elected to receive 90% of its management fee in stapled securities and the balance in cash.

Far East H-BT is dormant and the value of the Far East H-BT Trust Property is less than S\$ 50 million, and that, as a result, no Trustee-Manager fees are payable to the Trustee-Manager of Far East H-BT.

With the above-mentioned issue of new stapled securities, the REIT Manager holds an aggregate of 42,245,756 i.e. 2.35% of Far East H-Trust stapled securities and the total number of Far East H-Trust stapled securities in issue is 1,801,414,756 as at the date of this announcement.
