The SGX core ESG metrics, are a set of 27 metrics published by the Singapore Exchange. The recommended list is intended to guide sustainability reporting towards a standardised format for issuers and investors, and is mapped against globally-accepted sustainability reporting frameworks such as the Global Reporting Initiative (GRI). As a public listed company on the mainboard of the Singapore Exchange, Olam Group Limited (formerly known as Olam International Limited) has reported on sustainability metrics since before the launch of the SGX core ESG metrics. This index references the latest version of the SGX core ESG metrics available at the time of publication (April 2025).
