Rangi Management Limited ("Rangi") is held by Fusion Investment Holdings Limited ("Fusion"), which in turn is indirectly held by Highvern Trustees Limited ("Highvern") as trustee of the Scuderia Trust through bare trustees, Magnus Nominees Limited ("Magnus") and Fidelis Nominees Limited ("Fidelis"). Tasburgh Limited ("Tasburgh") is also indirectly held by Highvern, as trustee of the Scuderia Trust, through bare trustees, Magnus and Fidelis.

The beneficiaries of the Scuderia Trust are Farida Gustimego Santosa, her children (Renaldo Santosa, Gabriella Santosa, Mikael Santosa and Raffaella Santosa) and the remoter issuer of the late Handojo Santosa. Pursuant to Section 4 of the SFA, the beneficiaries of the Scuderia Trust are deemed to have an interest in the Japfa Shares held by Rangi and Tasburgh.
