ALLOTMENT, ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Keppel REIT Management Limited, in its capacity as manager of Keppel REIT (the "Manager"), wishes to announce that 7,361,332 new units in Keppel REIT ("Units") have been allotted and issued at an issue price of S\$1.1393 per new Unit to eligible unitholders of Keppel REIT ("Unitholders") who have elected to participate in the distribution reinvestment plan (the "DRP") in respect of the distribution of 1.42 cents per Unit for the period from 1 April 2017 to 30 June 2017 (the "Distribution").

Distribution payments to eligible Unitholders who did not elect to participate in the DRP and noneligible Unitholders will be paid in cash on 29 August 2017.

The new Units will be allotted, issued and credited as fully paid on 29 August 2017, and will be listed and quoted on the Main Board of Singapore Exchange Securities Trading Limited (the "**SGX-ST**") at 9.00 a.m. on 29 August 2017.

The new Units will rank *pari passu* in all respects with the existing Units in issue on 28 August 2017. Following the issue of the new Units, the total number of Units in issue will increase from 3,347,507,915 to 3,354,869,247.
