SUBSCRIPTION OF RIGHTS SHARES IN EDUC8 GROUP SDN BHD, AN ASSOCIATED COMPANY

The Board of Directors ("Board") of Plato Capital Limited (the "Company", together with its subsidiaries, the "Group") wishes to announce the completion of its subscription of 1,323,551 Rights Shares (as defined herein) ("Subscription") through its wholly owned subsidiaries, Asian Strategic Investments Group Limited ("ASIG") and Plato Capital Sdn Bhd ("PCSB"), pursuant to the rights issue of up to 3,000,000 new ordinary shares in the capital of Educ8 Group Sdn Bhd ("Educ8") ("Rights Shares"), an associated company of the Group, at the issue price of RM1.00 for each Rights Share offered by Educ8 ("Rights Issue"). A total of 1,323,551 Rights Shares were subscribed and it represents 0.993% of Educ8's enlarged issued and paid-up share capital upon completion of the Rights Issue.

Following the completion of the Rights Issue, the aggregate shareholdings of ASIG and PCSB in Educ8 had increased from 44.120% to 44.134%. The total cash consideration for the Subscription of RM1,323,551 (equivalent to approximately S\$441,616¹) was funded by the Group's internally generated funds.

Educ8 had undertaken the Rights Issue to provide further funding to its wholly own subsidiary Epsom College Malaysia Sdn Bhd to meet its working capital requirements including but not limited to defraying of operating costs and payment of trade and other payables.

The Educ8's latest consolidated audited net tangible asset is RM59,254,218 as at 31 December 2016.

The Subscription is not expected to have a material effect on the earnings per share and net tangible assets per share of the Group for the financial year ending 31 December 2018.

Mr Lim Kian Onn is a Director and controlling shareholder of the Company and also a managing director and controlling shareholder of ECM Libra Financial Group Berhad ("ECMLIB"). ECMLIB is an associated company of the Group and has a 10.000% interest in Educ8. Following the Rights Issue of which ECMLIB has also participated, ECMLIB's interest in Educ8 had increased to 10.004%. Save as disclosed, none of the Directors or controlling shareholders of the Company have any interest, directly or indirectly in the Rights Issue.
