Easy Direct International Limited ("Easy Direct") is incorporated for the purpose of allowing the employees of China Shenshan Orchard Holdings Co. Ltd. (the "Company") and its subsidiaries (collectively, the "Group") to acquire and hold shares in the capital of the Company through Easy Direct. Mr Zhao Chichun is the sole shareholder of Easy Direct.

On 8 March 2022, on the instructions of the belowmentioned employees of the Group, Easy Direct acquired an aggregate of 7,500,000 ordinary shares in the capital of the Company ("Shares") held by Bright Sing Group Limited via a married deal. Through Easy Direct, Mr Zhao Chichun (Executive Director of the Company) and Mr Hu Chao (Executive Director and Chief Executive Officer of the Company) each acquired 3,000,000 Shares (representing approximately 3.76% of total number of issued Shares), and the remaining 1,500,000 Shares (representing approximately 1.88% of total number of issued Shares) were acquired by other employees of the Group.

Easy Direct is deemed to have an interest in the 7,500,000 Shares held through a nominee account with UOB Kay Hian Private Limited.
