### **CHANGE IN FIRST COURT HEARING DATE**

### 1. INTRODUCTION

CapitaLand Commercial Trust Management Limited (the "<u>CCT Manager</u>"), as manager of CapitaLand Commercial Trust ("CCT"), refers to:

- (a) the announcement dated 22 January 2020 (the "Joint Announcement") issued by the CCT Manager and CapitaLand Mall Trust Management Limited, as manager of CapitaLand Mall Trust ("CMT"), in relation to the proposed merger of CMT and CCT through the acquisition by CMT of all the issued and paid-up CCT Units by way of a trust scheme of arrangement, to be effected in accordance with the Singapore Code on Take-overs and Mergers; and
- (b) the announcement dated 10 March 2020 issued by the CCT Manager informing CCT Unitholders of the date of the first court hearing (the "First Court Hearing Date Announcement").

Unless otherwise defined, all capitalised terms used and not defined herein shall have the same meanings given to them in the Joint Announcement.

# 2. CHANGE IN FIRST COURT HEARING DATE

As mentioned in the First Court Hearing Date Announcement, an application in HC/OS 292/2020 (the "<u>Trust Scheme Application</u>") had been filed with the Court for leave to convene the Trust Scheme Meeting and that the Court had directed that the Trust Scheme Application be fixed for hearing at 10.00 a.m. on 18 March 2020.

The CCT Manager now wishes to update CCT Unitholders that the Court has today directed that the Trust Scheme Application be rescheduled for hearing at 10.00 a.m. on 17 March 2020.

# 3. DOCUMENTS FOR INSPECTION

In view of the rescheduled first court hearing, a copy of the Trust Scheme Application will now be made available for inspection at the registered office of the CCT Manager at 168 Robinson Road, #30-01 Capital Tower, Singapore 068912 during normal business hours up to (and including) the date of the first court hearing, being 17 March 2020<sup>1</sup>.
