**UPDATE ANNOUNCEMENT – JUDICIAL MANAGEMENT**

The Board of Directors (the "**Board**") of Acesian Partners Limited (the "**Company**" and together with its subsidiaries, the "**Group**") refers to the announcements dated 24 January 2017, 24 July 2017, 24 August 2017, 7 September 2017, 11 October 2017, 25 October 2017, 20 November 2017, 14 February 2018, 1 June 2018 and 22 October 2018 ("**Announcements**") in relation to *inter alia*, Acesian Star (S) Pte. Ltd, its wholly-owned subsidiary ("**ASPL**"), being placed under judicial management.

*Unless defined otherwise, capitalised terms used in this announcement shall have the meanings ascribed to them in the Announcements.*

The Board wishes to update that pursuant to the applications made by the Additional Judicial Manager of ASPL, Ms. Muk Siew Peng, for a further extension of the Judicial Management Order, the Company had received the notice of extension today informing that the High Court of Singapore had on 9 November 2018 ordered that the Judicial Management Order be further extended for a period of 180 days to 11 May 2019.

Further to the respective applications by the joint and several Judicial Managers of ASPL namely Mr Andrew Grimmett and Mr Lim Loo Khoon, and the Company as referred to in the Company's announcement on 22 October 2018, the Board wishes to update that a Pre-Trial Conference is scheduled on 13 December 2018 and the hearing date for the applications is scheduled on 10 January 2019.

The Company will make further announcements to keep shareholders updated on any material developments on a timely basis.
