Each stapled security of CLAS comprises one unit in CapitalLand Ascott REIT and one unit in CapitalLand Ascott BT. The manager of CapitalLand Ascott REIT is CapitalLand Ascott Trust Management Limited and the trustee-manager of CapitalLand Ascott BT is CapitalLand Ascott Business Trust Management Pte. Ltd..

On 31 October 2023, it was announced that the Issuer, a wholly owned subsidiary of DBS Trustee Limited, in its capacity as trustee of CapitalLand Ascott REIT, had priced S\$100,000,000 in principal amount of 4.223 per cent Notes due 2028 (the "Notes") under its S\$2,000,000,000 Multicurrency Debt Issuance Programme. The Notes were listed and quoted on Singapore Exchange Securities Trading Limited on 7 November 2023.
