The consideration of Hangzhou Kesheng Acquisition was arrived at on a willing buyer, willing seller basis and shall be fully paid in three instalments.

Principal activity : Property development, property management and other related activities

The net tangible asset value of Hangzhou Kesheng Acquisition based on the latest available management accounts was RMB14,992,425.

The consideration of Hangzhou Keyi Acquisition was arrived at on a willing buyer, willing seller basis and shall be fully paid in three instalments.

Details of Hangzhou Keyi are set out below:-

Registered capital: RMB50,000,000

Principal activity : Property development, property management and other related activities

The net tangible asset value of Hangzhou Keyi Acquisition based on the latest available management accounts was RMB14,992,425.

Each of the above transaction is not expected to have any material impact on the net tangible asset or earnings per share of the Company for the financial year ending 31 December 2017.

None of the directors nor controlling shareholders of the Company has any interest, direct or indirect, in the above transactions, save for their respective interests, through their shareholdings and/or directorships, as the case may be, in the Company.
