We believe that with Beck's deep expertise in system integration and technology-related areas, wide international experience, as well as strong leadership and energy, he is well placed to take NeraTel to the next stage of its growth."

Mr. Beck Tong Hong brings with him over 17 years of corporate leadership and senior management experience in product management and large scale program management. He has deep familiarity of the Group and was previously its Vice President for Network Infrastructure business for three years. He had worked at Singapore Telecommunications Ltd, Defense Science Technology Agency of Singapore and PT Smartfren Tbk, prior to joining NeraTel.

Mr. Beck holds a Diplôme d'Ingénieur in Electrical and Electronics Engineering degree from Ecole Superieure d'Ingenieurs en Genie Electrique and a Diplôme d'Etudes Approfondies in Optoelectronics from Institut National des Sciences Appliquées de Rouen, both in France.

Mr. Beck Tong Hong, CEO of NeraTel, said, "I would like to thank the Board for the mandate to lead NeraTel. Achieving sustainable earnings remains central to the Group's strategy. I look forward to working closely with our experienced team at NeraTel to deepen our expertise in identified areas of growth such as Network Security, Data Centre, Software Defined Networking and Cloud Infrastructure for our Network Infrastructure business segment. As for our Wireless Infrastructure Network segment, we will capitalise on the digitisation wave and need for greater bandwidth, speed and network coverage to grow our business."
