S i2i ANNOUNCES IMPROVED 3Q2014 PERFORMANCE

- Positive Operating EBITDA of US\$0.1 million;
- Revenue of US\$92.7 million representing 4% improvement from the previous quarter;
- Net losses reduced to US\$1.4 million representing 17% improvement from the previous quarter.

Singapore, November 13, 2014 – S i2i Limited ("S i2i", and together with its subsidiaries, collectively, the "Group"), announced an improved set of results for the three months ended September 30, 2014 ("3Q2014"). For 3Q2014, the Group achieved an EBITDA of US\$0.1 million which improved from negative EBITDA of US\$2.1 million for previous quarter ("2Q2014"), and narrowed its net losses to US\$1.4 million, from US\$1.7 million in 2Q2014.

The Group reported a turnover of US\$92.7 million for 3Q2014, compared to US\$89.0 million achieved in 2Q2014. Revenue from the distribution of operator products and services improved in Indonesian Rupiah ("IDR") terms to IDR882,483 million from IDR821,229 million in the preceding quarter.

The Group's financial and liquidity conditions remain robust, with net cash of US\$23 million as of September 30, 2014.

Mr Dilip Modi, Chairman of S i2i, said, "Our strategy to grow profitable revenue is beginning to yield positive results. With a view towards returning to profitability in mind, the Group continues to focus on expanding our business in the distribution of operator products and services in Indonesia; and at the same time, leverage our
