Ltd. (the "**Transferee**").

The Scheme will be proposed in accordance with the terms stated in the implementation agreement dated 15 November 2019, further information of which can be found in the Company's announcements dated 15 and 25 November 2019. The consideration for the transfer of listing status will be satisfied by the issuance of new shares in the capital of the Transferee which are intended for *inter alia* distribution to creditors and shareholders of the Company.

Further information and the outcome of the Scheme Application will be announced in due course.

Monthly Update

The Judicial Managers wish to update shareholders that, apart from the aforesaid Scheme Application:

- 1. the Company has finalised its choice of an independent financial adviser ("**IFA**") to advise on the proposed Scheme, and the IFA appointed and works are in progress;
- 2. the Transferee has confirmed to the Company that a valuer has been appointed to perform a valuation on the Transferee's business, and such works are in progress;

- 3. the Transferee and the Company have applied to the Securities Industry Council for certain clarifications, rulings and/or confirmations in relation to the proposed Scheme, the outcome of which would be made known in due course; and
- 4. the Transferee and the Company are working towards a submission to IPO Admissions in January 2021.

The Judicial Managers have separately been apprised of various legal actions which the Company's key subsidiaries appear to be involved in, based on the outcome of searches conducted on websites maintained by the Supreme People's Court of China. A list of such legal actions are annexed to this announcement, none of which to the knowledge of the Judicial Managers have been disclosed by the former executive management of the Company.

The Company does not have ready funds or other resources available to the Judicial Managers to, amongst other, appoint professionals to advise and investigate to obtain further information on these legal actions, nor have they been able to take custody and/or control of the books, records and assets of the Company. No creditor nor shareholder of the Company have to date come forward to offer funding for further action to be conducted. In such circumstances, the Judicial Managers verily believe that the proposed Scheme for the transfer of the listing of the Company remains the only avenue through which there can potentially be some recovery for creditors and shareholders of the Company.

Further updates will be announced periodically and as and where there are other material developments.
