HLG holds 50% of the share capital of Elite Partners Holdings Pte. Ltd. ("EPH"). EPH holds 68% of the share capital of Elite Commercial REIT Management Pte. Ltd. (the "Manager"), which holds 1,913,751 Units in Elite Commercial REIT. Therefore, Micheal is deemed to be interested in 1,913,751 Units held by the Manager.

Ho Lee Group Trust ("HLGT") holds 35,882,406 Units. Micheal is a beneficiary of HLGT, and therefore is deemed to be interested in the 35,882,406 Units held by HLGT.

Micheal is also deemed interested in the 220,683 Units held by his wife, Kan Phui Lin.
