## SGX RegCo's Query 1

Please provide more background to Mr Toh's cessation as Executive Officer, including but not limited to whether there were concerns or disagreements which should be brought to the attention of shareholders.

## Company's Response

Similar to any other companies that undergo any form of recalibration and restructuring of their management team, the objective of such a leadership renewal exercise is to refresh its existing Executive Officers so as to pave the way for those who have proven track record in their respective functions to undertake the key leadership roles of the Group. As such, the Cessation is an outcome of the leadership renewal process. As disclosed in the Announcement, there are no concerns or disagreements with Mr Brayden Toh as he will remain as a key employee of the Group.

#### SGX RegCo's Query 2

It is stated that Mr Brayden Toh is responsible for overall procurement, production, quality and maintenance of the asphalt plant, construction waste recycling plant and other related machineries. Please elaborate on whether the Company intends to find a replacement for this role. If not, why not.

#### Company's Response

As stated in the Company's response to Query 1 above and with reference to the Announcement, Mr Brayden Toh will remain as an employee of the Company and continue to handle the above functions as per normal without any changes in his existing responsibilities, position, and compensation. As such, there are no intentions for the Company at this stage to find a replacement for this role.

Please clarify if there are any other changes to the Company's Executive Officers resulting from the recalibration and restructuring exercise.

#### Company's Response

Yes. The necessary announcement will be released in due course once the new appointment of an Executive Officer is finalised and after going through the due diligence and due approval process.
