- For Series 008, indicate your choice of Option C / D in Paragraph 1 or 3 (as applicable – see above instructions) of the Voting Instruction Form



Early Consent Bonus

If you submit your vote FOR BOTH Resolutions 1 AND 2* by 15 November 2017, 5.00 p.m., and Resolution 1 is passed, you qualify to receive 6,000 shares.
