Ltd., the Company has on 26 July 2019 and in compliance with paragraph 14 of the 8 May NOC, opened an escrow account with a local bank (the “**New Escrow Account**”). For the reasons set out at the Company’s response to Query 4, as set out in the Company’s announcement dated 30 July 2019, the Company is, at present, unable to place any cash and bank balances in excess of the Group’s operational requirements in the New Escrow Account.

- (b) the announcements of the Company on 23 May 2019, 25 May 2019, 28 May 2019 and 29 May 2019 in relation to escrow monies deposited with JLC.

The opening balance as at 1 Sep 2019 is not inclusive of the funds which have been deposited with JLC.

The Company is monitoring the situation closely and will take rigorous steps to protect its interests and the recovery of escrow funds of \$33.15 million from JLC. The Company will continue to provide further updates to shareholders on subsequent material developments.
