- 1. With the discontinuation of the “RWS Invites” membership programme, how does Resorts World Sentosa (“RWS”) intend to attract non-gaming guests to its attractions?**

As the region’s premier lifestyle destination, RWS offers a wide variety of leisure and hospitality experiences. As part of our RWS 2.0 expansion plans, we will be launching several new attractions such as the Minion Land in Universal Studios Singapore, Super Nintendo World, the Singapore Oceanarium, and new food and beverage and lifestyle experiences.

- 2. Is there any programme offered to previous “RWS Invites” programme members? Why did Genting Singapore (the “Company”) discontinue the “RWS Invites” programme? Are there off-peak or weekday programmes to encourage customers to visit and spend in RWS? Does RWS have any plan to revitalise the food and beverage offerings or carparking point redemptions to incentivise local customers to park at RWS?**

- 4. There was a recent news report that Japan is expected to approve Osaka, Japan as an integrated resort location, and plans to approve up to three integrated resort locations. As announced on 10 September 2021, the Company had previously pursued a bid to develop an integrated resort in Yokohama City, but this was discontinued when Yokohama City decided to cancel the Yokohama City integrated resort bid process.

The Company is not currently pursuing a bid to develop an integrated resort project in Osaka or in Japan.
