## CESSATION AND APPOINTMENT OF DESIGNATED MARKET MAKER

Dear Shareholder,

*Capitalised terms used in this document shall have the same meaning ascribed to them in the latest version of the Singapore prospectus of the Company (the “Prospectus”) unless the context otherwise requires.*

<sup>1</sup> The name of the Sub-Fund as it appears in the Luxembourg base prospectus relating to the Company and product annex of the Sub-Fund is “Xtrackers S&P 500 Inverse Daily Swap UCITS ETF”.

We write to inform you, on behalf of the board of directors of the Company (the “**Board of Directors**”):

1. Deutsche Bank AG, acting through its London branch will cease to be a Designated Market Maker (“**DMM**”) for the Sub-Funds with effect from 31 July 2020.
2. Societe Generale will be appointed as a new DMM for the Xtrackers FTSE Vietnam Swap UCITS ETF with effect from 1 July 2020.

As long as the Singapore Shares of the Sub-Funds are listed, quoted and traded on the Singapore Exchange Securities Trading Limited (“SGX-ST”), the Company shall ensure that at least one (1) DMM who is approved and registered by the SGX-ST as a DMM is appointed at all times in respect of that Sub-Fund.

The table below shows the DMM(s) for each Sub-Fund set out in the table with effect from 31 July 2020.
