**FOO FIGHTERS MAKES GRAND RETURN TO
SINGAPORE AFTER TWO DECADES**



SINGAPORE (16 May 2017) – UnUsUaL Entertainment Pte Ltd (“UnUsUaL Entertainment”), a wholly-owned subsidiary of UnUsUaL Limited (“UnUsUaL”) will be bringing international stadium/arena headliners Foo Fighters to Singapore’s National Stadium on 26 August 2017.

This marks the 11-time Grammy Award-winning American rock band’s grand return to Singapore after more than 20 years since their last performance here in 1996.

“The Foo Fighters concert marks the first western act UnUsUaL is promoting since our listing in April. We are excited to have this internationally-acclaimed rock band in Singapore. We will continue to bring events and concerts from the global stage to Asia,” said Mr Leslie Ong, Executive Director and CEO, UnUsUaL.

Comprising Dave Grohl, Taylor Hawkins, Nate Mendel, Chris Shiflett and Pat Smear, Foo Fighters' journey began humbly with a 1994 demo recorded by Dave that mutated into the band’s eponymous 1995 self-titled debut. In the 22 years that followed, the band has grown to become a dominant force on the global festival, stadium and arena circuit.

Foo Fighters' massive catalogue of gold and platinum albums have won 11 Grammy Awards, sold 25 million records and spawned anthems like "This Is A Call," "Everlong," "Monkey Wrench," "My Hero," "Learn To Fly," "All My Life," "Times Like These," "Best Of You," "The Pretender," "Walk," "These Days," "Something From Nothing" and more.
