Review of income statement of the Group for the nine months ended 30 September 2015 ("9M2015") as compared to the nine months ended 30 September 2014 ("9M2014") on total group (continuing and discontinued operations) basis

Revenue

There was no production and thus no revenue generated in all of our 3 plants for 9M2015.

Cost of sales, gross profit

As explained above, there was no production activities in all of our three plants during 9M2015. As such, there was no cost of sales and gross profit.

Other income

The decrease in other income for 9M2015 as compared to 9M2014 by RMB0.6 million was mainly due to the RMB0.6 million miscellaneous income in 9M2014.

Selling and distribution expenses

For both periods 9M2015 as compared to 9M2014 and 3Q2015 as compared to 3Q2014, our selling and distribution expenses decreased by 21.8% and 22.4% respectively. This was mainly due to no depreciation expenses charged to selling and distribution expenses for 9M2015 and 3Q2015.

General and administrative expenses

For 9M2015 as compared to 9M2014, our general and administrative expenses decreased by RMB42.8 million or 69.5%. The was mainly due to higher general and administrative expenses in 9M2014 arising mainly from the provision of RMB13.4 million allowance for impairment of trade receivables and RMB22.1 million allowance for impairment of advance to suppliers made in 3Q2014.

For 3Q2015 as compared to 3Q2014, our general and administrative expenses decreased by RMB40.9 million or 86.6%. The was mainly due to higher general and administrative expenses in 3Q2014 arising mainly from the provision of RMB13.4 million allowance for impairment of trade receivables and RMB22.1 million allowance for impairment of advance to suppliers made in 3Q2014

Finance expenses

As there was no borrowings, finance expenses was nil in 9M2015 and 9M2014.

Loss before income tax

Our loss before income tax decreased by 42.2 million or 69.0% for 9M2015 compared to 9M2014. The decrease was due mainly to the lower general and administrative expenses as explained above.

Our loss before income tax increased by RMB40.6 million or 86.5% for 3Q2015 compared to 3Q2014. The increase was due mainly to the lower general and administrative expenses in 3Q2014 as explained above.

Income tax expense

No income tax expense was recorded for 9M2015 and 3Q2015 as compared to RMB1.8 million provision in 9M2014 and RMB0.6 million provision in 3Q2014. This was due mainly to nil tax provision for our three subsidiaries in 9M2015 as there was no production and revenue generated.

Review of financial position of the Group as at 30 September 2015

Current assets

As at 30 September 2015, our total current assets were RMB39.4 million as compared to RMB39.6 million as at 31 December 2014. The decrease of RMB192,000 in current assets was due to the RMB79,000 decrease in cash and bank balances and RMB113,000 decrease in other receivables, which consisted of mainly prepayments and deposits. Assets held for sale remained unchanged at RMB39.4 million. Assets held for sale arose from the reclassification of property, plant and equipment and intangible assets held by the Group in Miluo and Xiangyin plants. Miluo and Xiangyin plants have received notifications from the government to cease their operations in the existing factories which are located in urban areas of the cities for the purposes of the re-development of the cities. As such, the property, plant and equipment and intangible assets amounting to RMB39.4 million located in these two plants were reclassified from non-current assets to "Assets held for sale" under current assets.

Non-current assets

Non-current assets include land use rights with net book value of RMB14.1 million as at 30 September 2015 and 31 December 2014 and property, plant and equipment with net book value of RMB5.2 million as at 30 June 2015 and 31 December 2014. With the halt in production activities in all of our three plants and with the classification of property, plant and equipment in our Miluo and Xiangyin plants to "assets held for sale", no depreciation expenses and amortisation expenses were recognized on our property, plant and equipment and land use rights in 9M2015.

As at 30 September 2015, the subsidiary of the Group, Hanshou, has not obtained the title deed of the land use right with net book value of RMB14.1 million (2014: RMB14.1 million) as the management is still engaged in on-going negotiation with local authority to transfer the title deed of the land use right from previous owner to the Group.

Current liabilities

Our current liabilities comprised other payables and income tax payable. As at 30 September 2015, total current liabilities were RMB74.8 million. The increase in current liabilities of 17.4 million or 30.4% from RMB57.4 million as at 31 December 2014 to RMB74.8 million as at 30 September 2015 was due to the increase in other payables arising mainly from the accrual of staff related costs.

Miluo and Xiangyin plants have received notifications from the government to cease their operations in the existing factories which are located in urban areas of the cities for the purposes of the re-

development of the cities. As such, the liabilities of these two subsidiaries operating in the 2 plants amounting to RMB38.1 million were reclassified from current liabilities to "liabilities directly associated with disposal group classified as held for sale".

As at 30 September 2015, other payables comprised mainly accruals and other payables amounting to RMB17.0 million, and amount due to shareholders of RMB7.0 million. The increase was due to timing differences in payments made to the other creditors and advances from shareholders.

As at 30 September 2015 and 31 December 2014, provision for tax amounted to RMB12.8 million. There was no tax provision provided for 9M2015 as there was no production and no revenue generated.

Total shareholders' equity

Total shareholders' equity as at 30 September 2015 amounted to approximately deficit of RMB16.0 million and comprised mainly share capital of RMB216.8 million and statutory reserve of RMB72.0 million and currency translation reserve of RMB1.6 million, offset by restructuring reserve of RMB102.8 million and accumulated losses of RMB203.6 million.

Review of cash flow statement for 9M2015

For 9M2015, the Group has a net cash outflow of RMB79,000 due to net cash used in operating activities amounting to RMB79 ,000.

For 3Q2015, the Group has nil cash outflow from operating activities.

Net cash used in operating activities

The decrease of RMB10.0 million in net cash used in operating activities for 9M2015 as compared to 9M2014 was due mainly to the increase of RMB17.5 million in other payables for 9M2015 as compared to the increase of RMB4.2 million in other payables for 9M2014.

The decrease of RMB4.3 million in net cash used in operating activities for 3Q2015 as compared to 3Q2014 was due mainly to the increase of RMB6.0 million in other payables for 3Q2015 as compared to the increase of RMB1.1 million in other payables for 3Q2014.
