The percentage interest before and after the acceptance of the offer is calculated based on 274,920,818 ordinary shares in the issued and paid-up capital of GYP Properties Limited ("Shares").

Pursuant to an irrevocable undertaking executed by Mr Tan Poh Leng Stanley ("ST") in favour of Rumah & Co. Pte. Ltd. (the "Offeror"), ST has agreed not to be paid in cash for the 9,732,900 Shares tendered in acceptance of the offer made by the Offeror.

Instead, the cash consideration payable to ST for his Shares will be set off against the issuance of new ordinary shares in the capital of the Offeror ("Offeror Shares") to Rumah Property Pte. Ltd. ("RP") and there will be an interest-free loan owing by RP to ST. ST owns 0.1% of the shares of RP and is director of RP.

The Offeror is a special purpose vehicle incorporated by 4 consortium members (who are also the 4 shareholders of the Offeror) for the purposes of the offer. RP is one such consortium member and shareholder of the Offeror and currently owns 218,750 Offeror Shares (representing 43.75%).
