CHANGE OF FINANCIAL YEAR END FROM 30 JUNE TO 31 DECEMBER

The Board of Directors (the "Board") of Metech International Limited (the "Company", and together with its subsidiaries, the "Group") wishes to announce the change of the financial year end of the Company from 30 June to 31 December. Following the change, the current financial year of the Company will end on 31 December 2023. Consequently, the next set of consolidated audited financial statements of the Group for the financial year ended 31 December 2023 will cover a period of 18 months from 1 July 2022 to 31 December 2023.

Rationale for the Change

The Company's decision to change the financial year end was arrived at after taking into consideration, amongst others, the following:-

- 1. the significant changes to the Board and the key management personnel in the year 2023;
- 2. the ability to reflect the new management's efforts and performance for a full financial year, taking into consideration the effective change of the Company's management and board members; and
- 3. the ability to facilitate better management of resources and internal processes for a smooth transition and to stabilize the flow of business operations and financial reporting.

In accordance with Section 198(4) of the Companies Act 1967, the Company has lodged a notice with the Registrar of Companies to update and specify the new date of 31 December as the last day of its current financial year. Since the new financial year-end date of 31 December 2024 is not longer than 18 months from the end of its last financial year ended on 30 June 2022, and since the Company has not changed its financial year end before, the approval of the Registrar is not required.

The Company has also effected a change in the financial year end of all its operating subsidiaries to be aligned with the Company's financial year end.
