UPDATE ON IMPACT OF BUSINESS PURSUANT TO THE MOVEMENT CONTROL ORDER IMPOSED BY THE GOVERNMENT OF MALAYSIA

*Unless otherwise defined, all capitalised terms used in this announcement shall bear the same meanings as in the Company's announcements dated 20 March 2020 and 25 March 2020 ("**Previous Announcements**").*

Further to the Previous Announcements, the Board of the Company wishes to inform that the Government of Malaysia has made an announcement to further extend the Movement Control Order ("**Order**") for the period from 18 March 2020 to 14 April 2020 for another 14 days up to 28 April 2020 ("**Extended Period**") to curb the spread of the COVID-19 infection in Malaysia.

The Group is currently still operating its restaurant business in Malaysia via take away and delivery services which is permitted under an exemption of the Order during the Extended Period. The limited operations during the Extended Period may have an adverse impact on the Group's financial results for the current financial year ending 31 December 2020, as well as its earnings per share and net tangible asset value or net asset value per share for the current financial year ending 31 December 2020.

The Company will continue to monitor the situation and further announcements will be made by the Company and the Board via SGXNET as and when there are material developments on the aforesaid matter in compliance with the Catalist Rules of the SGX-ST.
