



**PROPOSED ISSUANCE OF CONVERTIBLE NOTES AND NON-LISTED WARRANTS
– ALLOTMENT AND ISSUANCE OF 12,941,176 NEW SHARES**

*Unless otherwise defined, all capitalised terms used in this announcement shall have the same meanings as ascribed to them in the Company's announcements dated 31 March 2021, 23 April 2021 and 28 April 2022 ("**Announcements**") in relation to the proposed issuance of convertible notes and non-listed warrants ("**Proposed Issue**").*

Further to the Announcements, the Board wishes to announce that, pursuant to the terms of the Share Lending Deed, the Company had, on 12 May 2022, allotted and issued 12,941,176 new ordinary shares in the capital of the Company ("**New Shares**") to the Lender, as repayment of the same number of Lent Shares used for delivering the 12,941,176 Conversion Shares to the Subscriber, upon the conversion of twenty two (22) Issued Notes by the Subscriber.

Following the allotment and issuance of the New Shares, the total number of issued Shares of the Company increased from 2,611,041,900 Shares to 2,623,983,076 Shares. The New Shares are issued free from all pledges, liens, security interests and other encumbrances whatsoever and rank *pari passu* in all respects with and carry all rights similar to the existing issued Shares.

The New Shares are expected to be listed and quoted on the Catalist of the SGX-ST with effect from 9.00 a.m. on 17 May 2022. The AIP is not to be taken as an indication of the merits of the Proposed Issue, the Notes, the Warrants, the Conversion Shares, the Warrant Shares, the Company and/or its subsidiaries.
