(the "REIT Manager") on 7 May 2021 as payment for 50% of the REIT Manager's base fee for the period from 1 January 2021 to 31 March 2021 (the "7 May Issuance"). As a result of the 7 May Issuance, the REIT Manager has a direct interest of 216,712,343 Units (the "RM Units").

The REIT Manager is a wholly-owned subsidiary of OUE Limited ("OUE"). Accordingly, as a result of the 7 May Issuance, OUE has a deemed interest in the RM Units as well as (i) a deemed interest of 1,471,601,271 Units held by Clifford Development Pte. Ltd., a wholly-owned subsidiary of OUE, (ii) a deemed interest of 127,749,410 Units held by OUE Hospitality REIT Management Pte.
