Re: Ratings of PT Japfa Comfeed Indonesia Tbk

PT Fitch Ratings Indonesia ("Fitch") has revised the following ratings:

- National Long-Term Rating revised to 'A+(idn)' from 'AA-(idn)', Outlook Stable
- National Long-Term Rating of JAPFA Shelf-Registered Bonds II Phase I 2016 Issuance revised to 'A+(idn)' from 'AA-(idn)'
- National Long-Term Rating of JAPFA Shelf-Registered Bonds II Phase II 2017 Issuance revised to 'A+(idn)' from 'AA-(idn)'

The rating actions have been resulted from the recalibration of the Indonesian national rating scale. The recalibration reflects changes in the relative creditworthiness among the country's issuers following the upgrade of the Indonesia sovereign's Long-Term Issuer Default Rating to 'BBB' from 'BBB-' on 20 December 2017.

In issuing and maintaining its ratings, Fitch relies on factual information it receives from issuers and underwriters and from other sources Fitch believes to be credible. Fitch conducts a reasonable investigation of the factual information relied upon by it in accordance with its ratings methodology, and obtains reasonable verification of that information from independent sources, to the extent such sources are available for a given security or in a given jurisdiction.
