("Britten") is a wholly-owned subsidiary of Lennon Holdings Limited ("Lennon"), and Lennon is a wholly-owned subsidiary of SIHL. Accordingly, Rajgopal Rajkumar was originally deemed to have an interest in the units of Parkway Life REIT held by Britten.
