1. INTRODUCTION

The board of directors of Mapletree Commercial Trust Management Ltd., as manager of Mapletree Commercial Trust ("**MCT**", and as manager of MCT, the "**MCT Manager**" or the "**Manager**"), refers to:

- (a) the joint announcements dated 31 December 2021 and 28 January 2022 (the "**Joint Announcements**") issued by the MCT Manager and Mapletree North Asia Commercial Trust Management Ltd., as manager of Mapletree North Asia Commercial Trust ("**MNACT**" and the manager of MNACT, the "**MNACT Manager**"), in relation to the proposed merger of MCT and MNACT (the "**Merger**"), to be effected through the acquisition by MCT of all the issued and paid-up units of MNACT (the "**MNACT Units**") by way of a trust scheme of arrangement (the "**Trust Scheme**") in accordance with the Singapore Code on Take-overs and Mergers (the "**Code**"); and

The MNACT Manager has today issued an announcement (the "**MNACT Notice of Change in First Court Hearing Date**") updating the MNACT Unitholders that the Court has directed that the Trust Scheme Application be rescheduled for hearing at 10.00 a.m. on 21 February 2022.
