The change in interest which is the subject of this notification is due to the vesting of 560,534 share awards pursuant to the Singapore Technologies Engineering Performance Share Plan 2010 ("PSP") and Singapore Technologies Engineering Restricted Share Plan 2010 ("RSP").

As at 23 March 2020, the total number of shares underlying the options/awards held after the change is up to 2,942,802 which comprises the following:

(a) up to 2,454,702 shares are comprised in the conditional PSP Award of performance shares, subject to performance targets set over a three-year period, pursuant to the PSP. A minimum threshold performance is required for any performance share to be released. At the time of the award, the base number representing 100% of the award is 1,443,943 shares. The actual number of performance shares to be released is capped at 170% of the conditional PSP Award;

(b) 275,392 shares are unvested restricted shares to be released according to the stipulated vesting periods pursuant to the RSP; and

(c) 212,708 shares will vest annually over four years, subject to the recipient continued employment with the Group and maintaining a satisfactory performance rating for the financial year preceding each tranche of vesting pursuant to the RSP.

The percentage interests shown in Item 8 above are calculated based on 3,114,464,822 issued shares in the capital of Singapore Technologies Engineering Ltd as at 23 March 2020 (excluding treasury shares).
