Ley Choon clinches S\$19.6 million Contract from PUB for the replacement of water mains

- Ley Choon to supply and install potable water pipeline in selected areas around Singapore
- Project to commence in 2018 and is expected to last for 24 months

Singapore, 12 December 2017 – Catalist-listed Ley Choon Group Holdings Limited ("Ley Choon" or the "Company", and together with its subsidiaries, the "Group") is pleased to announce that the Group has bagged a new contract for S\$19.6 million from the Public Utilities Board ("PUB") for the replacement of water mains.

This contract involves the supply and laying of steel potable water pipelines. The project will employ the traditional and proven open, cut and backfill method, which the Group has over several years of expertise having done many similar projects before.

Mr Toh Choo Huat, Executive Chairman and Chief Executive Officer of Ley Choon, said "We are delighted to be awarded another pipe-laying project from PUB, which has been our client for over 20 years.

Our key long term objective is to not just to build a strong order book but establish sustainable and balanced growth as we continue to improve and enhance our financial position. In the near-term, we intend to focus on deepening our core competencies and capabilities which will put us in a strong position to secure new contracts, especially with the Government's increase investment in public sector infrastructure and construction projects."

When completed, the new pipelines will improve flow and pressure of water supply to the residents and businesses in the respective areas.

The new contract is expected to boost the Group's order book value of S\$139 million which was announced on 13 November 2017.
