UPDATE ON THE GROUP'S BUSINESS DISRUPTIONS DUE TO GOVERNMENT IMPOSED HEIGHTENED SAFE DISTANCING MEASURES PURSUANT TO COVID-19

The board of directors (the "**Directors**") of Tritech Group Limited (the "**Company**") and together with its subsidiaries, the "**Group**") wishes to update shareholders of the Group on the impact that the recent coronavirus disease outbreak ("**COVID-19**") may have on its businesses.

The Government of Singapore (the "**Government**") had on 3 April 2020 announced heightened safe distancing measures¹ (the "**Order**") to contain the spread of the virus. In particular, all businesses, other than those providing essential goods and services, will be closed for the period from 7 April 2020 to 4 May 2020 (the "**Period**") or such extended period as may be determined by the Government. As such, the Group's engineering and corporate businesses in Singapore that do not fall within the list of Essential Services¹ as prescribed under the Order will be closed during this Period.

In view of the foregoing, there will be significant disruptions to the Group's business and operations, including closure of its office and stoppage of work at its various project sites, which is expected to adversely impact the Group's revenue and financial performance during the Period. The Company is not able to assess the actual extent of the financial impact at this juncture but will closely monitor the COVID-19 situation and provide further updates to shareholders as and when any material developments arise.

During this Period, the Group has implemented its business continuity plan, including work from home arrangements, where appropriate, and looks forward to resuming normal operations as soon as it is appropriate to do so.

Shareholders and potential investors are advised to exercise caution when trading in the shares of the Company. Persons who are in doubt as to the action they should take should consult their legal, financial, tax or other professional advisers.
