**APPROVAL FROM THE ACCOUNTING AND CORPORATE REGULATORY AUTHORITY
FOR EXTENSION OF TIME TO HOLD THE ANNUAL GENERAL MEETING OF THE
COMPANY AND FILE ANNUAL RETURN FOR THE FINANCIAL YEAR ENDED 31
DECEMBER 2021**

The Board of Directors (the “**Board**” or the “**Directors**”) of Atlantic Navigation Holdings (Singapore) Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) refers to the Announcement dated 7 April 2022 in respect of the applications for extension of time:-

- (i) through its Sponsor, made application to the Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) for a 2-month extension of time for the Company:
 - (a) to hold its Annual General Meeting (“**AGM**”) for the financial year ended 31 December 2021 (“**FY2021**”) by 29 June 2022;
 - (b) to issue its Annual Report for FY2021 incorporating the Sustainability Report for FY2021 by 14 June 2022; and
 - (c) to release its unaudited financial statements for the first quarter ended 31 March 2022 by 15 July 2022.
- (ii) made application to the Accounting and Corporate Regulatory Authority (“**ACRA**”) for:
 - (a) a 60-day extension of time under Section 175(2) of the Companies Act 1967 of Singapore (“**Companies Act**”) to hold the Company’s AGM for FY2021 by 29 June 2022 (from the deadline of 30 April 2022); and
 - (b) a 60-day extension of time under Section 197 of the Companies Act to file its Annual Return in respect of FY2021 by 30 July 2022 (from the deadline of 31 May 2022).

The Board wishes to inform that ACRA has on 12 April 2022 approved the Company’s application to hold its AGM for FY2021 by 29 June 2022 and file its Annual Return for FY2021 by 30 July 2021, under Section 175(2) and 197 of the Companies Act respectively.

The Company will make an announcement on the outcome of its application to SGX-ST in due course.
