

## **OFFICIAL OPENING OF DALIAN AOXIN QUANMIN STOMATOLOGY HOSPITAL**

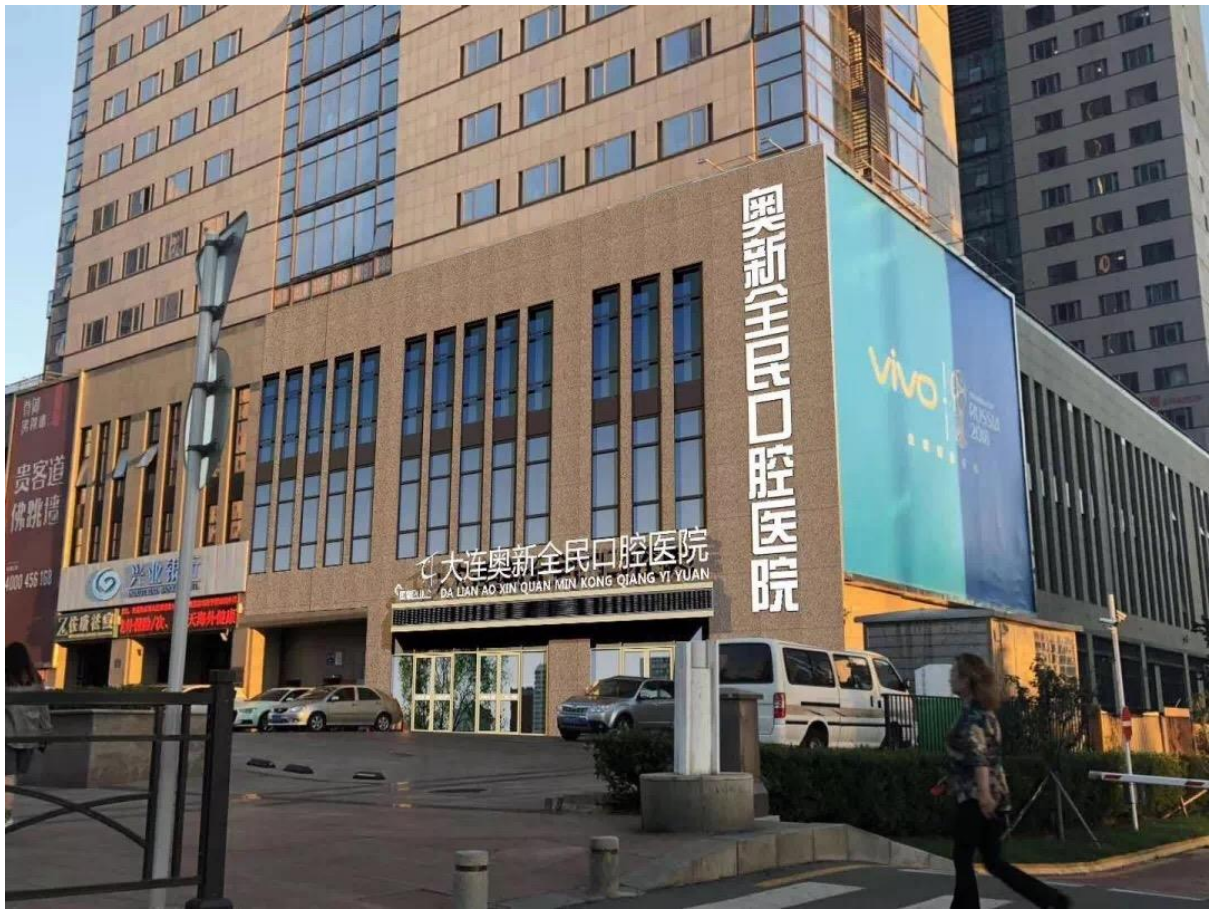
**Singapore, 31 Jul 2019** – Catalist-listed **Aoxin Q&M Dental Group Limited** (the “**Company**” and together with its subsidiaries, the “**Group**”), a leading provider of private dental services, distributor of dental equipment and supplies as well as provider of laboratory services in Liaoning Province, Northern PRC, is pleased to announce the official opening of its dental hospital, Dalian Aoxin Quanmin Stomatology Hospital Co., Ltd (the “**Hospital**”). The opening ceremony was officiated by Singapore Ministers and Liaoning officials. Singapore ministers include Minister for the Environment and Water Resources, Mr Masagos Zulkifli and Singapore Minister of State, Ministry of Foreign Affairs & Ministry of Social and Family Development, Mr Sam Tan Chin Siong. Liaoning officials consist of Member of the Standing Committee of the Dalian Municipal Party Committee, Secretary of the Party Working Committee of the New District, and Director General of Jinpu New Area Administrative Committee, Mr Li Pengyu, Dalian Vice Mayor, Mr Jin Guowei and Deputy Inspector-General of Liaoning Provincial Department of Commerce, Mr Zhang Yi.

The Hospital is located in the city of Dalian, Economic and Technological Development Zone, JinMa Road. Dalian is an important economic, trade, port, industrial and tourist city along the eastern coast of China which attracts a large number of foreign investors. While the demand for high end dental services has been increasing, there are currently no foreign hospitals that can provide a high standard of dental services in this area. The Hospital occupies two storeys of a standalone building with floor area of more than 2,000 m<sup>2</sup>, comprising of 20 VIP treatment rooms and a Children’s Dental Care Centre. It is also the first private dental hospital with a Children’s Dental Care Centre of this scale in Dalian which allows the Group to further entrench its presence in North Eastern China.

The Hospital will provide high quality and comprehensive dental healthcare services to local and foreign patients. The Hospital uses state-of-the-art treatment technology to provide a broad spectrum of dental care and treatment including endodontic, orthodontic, periodontics, paedodontics and dental surgery, to meet a wide variety of specialist dental service needs. The Hospital uses European and USA dental equipment including Cone Beam Computed Tomography scanner, CAD/CAM system, Erbium laser and digital panoramic X-ray machine. The Hospital is set up in accordance with internationally recognised standards emphasising on hygiene and providing a comfortable environment, with a focus on the provision of dental services for children.

As of this date, the Group has 17 dental centres, comprising 6 dental hospitals and 11 polyclinics. The dental centres are located in eight (8) different cities in Liaoning Province, Northern PRC, namely, Shenyang, Huludao, Panjin, Gaizhou, Zhuanghe, Jinzhou, Dalian and Anshan. The Group’s dental equipment and supplies distribution network covers the Liaoning, Heilongjiang and Jilin Provinces in the Northern PRC.
