**SECOND SUPPLEMENTAL DEED TO THE CONDITIONAL SALE AND PURCHASE AGREEMENT  
IN RESPECT OF THE PROPOSED ACQUISITION OF 100% OF THE ISSUED SHARE CAPITAL OF  
SHANAYA ENVIRONMENTAL SERVICES PTE. LTD.**

*Unless otherwise expressly defined herein, all capitalised terms and references have the same meaning as ascribed to them in the announcement made by the Company on 29 September 2020 and 23 June 2021.*

The Board wishes to announce that the Parties had, on 30 December 2021, entered into a second supplemental deed to the SPA dated 29 September 2020 (the “**2<sup>nd</sup> Supplemental Deed**”), to amend the terms of the SPA on the terms and subject to the conditions set out in the 2<sup>nd</sup> Supplemental Deed.

Clause 5.2 of the SPA was amended pursuant to the 2<sup>nd</sup> Supplemental Deed (insertions in underline and deletions in strikethrough):

*“The Purchase Consideration shall be satisfied where (i) within ~~twelve (12)~~ twenty-four (24) months from the Completion Date, the Purchaser pays the Cash Consideration in full to the Vendors at a time to be decided by the Purchaser, and (ii) on the Completion Date, the Purchaser issues and allots the Consideration Shares to the Vendors.”*

Except to the extent expressly varied, restated, or amended by the provisions of the 2<sup>nd</sup> Supplemental Deed, the terms and conditions of the SPA were confirmed and shall remain in full force and effect. The SPA and the 2<sup>nd</sup> Supplemental Deed shall be read and construed as one document and the 2<sup>nd</sup> Supplemental Deed shall be considered as part of the SPA.

A copy of the SPA and the 2<sup>nd</sup> Supplemental Deed will be made available for inspection during normal business hours at the registered office of the Company at 3A Tuas South Street 15, Singapore 636845 for a period of three (3) months from the date of this announcement.

The Company will make subsequent announcements to update Shareholders when there are material updates as may be necessary or appropriate.
