The entire issued and paid up capital of Phileo Capital Limited and 3C Investments Limited have been transferred from TMF Trustees Singapore Limited to ZICO Trust (S) Ltd.

As of 1 March 2024, Phileo Capital Limited is the registered holder of 224,808,000 ordinary shares of the Company. Pursuant to Section 4 of the Securities and Futures Act (Chapter 289), Tong Kooi Ong is deemed interested in the shares held by Phileo Capital Limited because Phileo Capital Limited is wholly-owned by ZICO Trust (S) Ltd, the trustee of a family trust of which Tong Kooi Ong is the sole beneficiary.

Pursuant to Section 4 of the Securities and Futures Act (Chapter 289), Tong Kooi Ong is also deemed interested in the 73,439,000 Shares held by Genghis S.a.r.I. because Genghis S.a.r.I. is wholly-owned by 3Cs Investments Limited, which in turn is wholly-owned by ZICO Trust (S) Ltd, the trustee of a family trust of which Tong Kooi Ong is the sole beneficiary.
