As part of the restructuring, TCTPL acquired shares representing more than 50 per cent. of the issued share capital of Grange Investment Holdings Private Limited, a substantial shareholder of FJB which is deemed interested in the FJB shares held by Raffles Investments Limited ("RIL"). By virtue of this, TCTPL has a deemed interest in the FJB shares held by RIL.
