APPOINTMENT OF CHIEF SCIENTIST AT DIGITAL LIFE LINE PTE. LTD., A SUBSIDIARY OF DISA DIGITAL SAFETY PTE. LTD.

Further to the announcement pertaining to the appointment of directors and change in shareholdings at Digital Life Line Pte. Ltd. ("DLL") dated 29 December 2021 and 12 January 2022, the board of directors (the "Board") of the Company wishes to announce the appointment of Dr. Poh Weijie as a Chief Scientist of DLL.

Dr. Poh was previously the Head of Global Clinical and Medical Operations in a health-tech company with the leading migraine tracking mobile application in the world. He was responsible for initiating the first large-scale real-world migraine studies done fully virtually on a digital platform with MNCs such as AbbVie and Nestlé Health Sciences. Prior to that, Dr. Poh was an Entrepreneur-in-Residence at Duke-NUS Medical School, responsible for business development for an infectious disease technology platform. Before that, Dr. Poh co-founded and was the CEO of a universal cervical cancer vaccine spinoff from the Johns Hopkins University, during which the company secured federal and private investment for a Phase 1 clinical study in the United States.

Dr. Poh has a Ph.D. in Pathobiology from the Johns Hopkins University and completed his postdoctoral training at Harvard Medical School. To date, he has co-authored 12 peer reviewed publications in the fields of sequencing, medical diagnostics, real-world evidence, and cancer biology.

As the Chief Scientist, Dr. Poh, is responsible for the R&D pipeline, diagnostic kit development, and regulatory operations across DLL's portfolio.

For the avoidance of doubt, the appointment announced herein is not considered as appointment of key persons under Rule 704(6) of the Listing Manual Section B: Rules of Catalist of the Singapore Exchange Securities Trading Limited.
