Please provide detailed bases for the Nominating Committee to arrive at an assessment that Mr. Foo satisfies the independence requirements under Listing Rule 210(5)(d) and is able to discharge his duties as an independent director effectively, in view of, amongst others, his familiarity with the directors, substantial shareholders and management of Ossia.

Company's Response

The Nominating Committee ("NC") conducted the review of his independence and was satisfied that his appointment would be in compliance with the SGX Code of Corporate Governance. The NC obtained confirmation that:

- 1. He or any of his immediate family members do not have significant shareholdings in Ossia;
- 2. There have been no transactions between the Ossia Group and him; and
- 3. There are no relationships with him that could interfere with the exercise of his independent business judgement in the best interest of the company.

NC also discussed his current directorships in other listed & unlisted companies, background and principal qualifications, and details of his principal commitments.

The NC received confirmation that he would be able to commit sufficient time to discharge his duty as a non-executive director.

On this basis, despite his familiarity with most of the directors, substantial shareholders, and management of Ossia, the NC concluded that Mr Foo would provide different skills & competencies to fulfill the expectations & requirements for Board diversity.
